1. *Navajo language assistance will be provided at Aneth, Red Mesa, Teec Nos Pos, Mexican Water, Oljato, Dennehotso and Navajo Mountain Chapter houses and at White Mesa Community Center. Liaisons will interpret the entire Notice of 2026 General Election from the written English language to the Navajo language.*
