## **General Purpose**

San Juan Public Health strengthens trusted bridges to health and wellness for all of San Juan County. As part of a dynamic, service-oriented team, the Epidemiologist identifies gaps and strengths in these bridges so that San Juan Public Health and its partners can better promote health and wellness in the county. The primary roles of the Epidemiologist are to gather and monitor disease-related data (for all causes of morbidity and mortality), investigate communicable disease outbreaks, and strategically link data and reports as part of an ongoing community health needs assessment process.

#### **Essential Functions**

- Plan, organize and conduct field studies and surveillance of communicable or chronic diseases, injuries or conditions
- Determine the patterns of communicable or chronic diseases, injuries or conditions in the community
- Participate in local, state, tribal epidemiology-related meetings and provide input, updates, and summaries representing San Juan County to the Public Health Directors, partners, and public, as needed
- Provide meaningful statistical data visualizations designed for professional and public consumption
- Stay current on disease-related data collection methods, trends, and analysis of the data, and act as a subject matter expert to answer questions about specific changes, trends, or communities, as needed
- Perform infectious disease investigations in a timely manner when assigned
- Recognize specific questions that are asked in infectious disease case interviews and contact tracing, become conversant with the data that is collected
- Assist in evaluating effectiveness and impact of public health programs
- Partner with local hospitals and a comprehensive group of community partners in an ongoing, action-oriented community health needs assessment process
- Investigate infectious disease, including sexually transmitted disease (STD), cases within San Juan Public

- Health's jurisdiction to reduce and control the spread of disease.
- Be cross-trained to respond to COVID-19, HIV, STDs, and other infectious or emerging diseases, and conduct disease investigations including, case investigation, contact tracing, linkage to treatment, referrals, case management, and outbreak response.
- Acquire required credentials, trainings, and certifications per contract requirements, for example, for outbreak responses.
- Disseminate disease-related curriculum in healthcare and long-term care facilities within the health department's jurisdiction as needed.
- Enter and track case/surveillance data within EpiTrax and other relevant databases.
- Work with San Juan Public Health and partners to carry out assessments and implement strategies to prevent and protect vulnerable populations (such as persons with disabilities, people experiencing homelessness, racial and ethnic minority communities, older adults, etc.)

#### **Work Environment**

Regularly sits at a desk; walks, stands, or stoops, uses tools or equipment requiring a high degree of dexterity; works for sustained periods of time maintaining concentrated attention to detail. Work is often performed in an office or other environmentally controlled room. Work requires frequent contact with the public in public settings with some risk of exposure to infectious diseases and with individuals that may be angry, agitated, or otherwise upset.

Occasionally lifts, carries, pushes, pulls or otherwise moves objects weighing up to 25 pounds. Position requires driving to different locations throughout the County as needed. Continuing education, such as earning a Certified Health Education Specialist credential, is provided when related to grant activities.
